



COVID-19 & Other Public Health Programming Policies

Summer Dance Day Camp 2023
Effective August 2023

The RWB School will deliver in-person dance programming during Summer Dance Day Camp 2023. Online programming will only be offered if COVID-19 or other Public Health restrictions/policies make it impossible for students to attend Summer Dance Day Camp 2023 in person.

Due to evolving COVID-19 or other Public Health restrictions/policies, the RWB School reserves the right to modify programming. Changes or modifications to programming may include but are not limited to the cancellation of specific classes or adjustments to camp times and duration.

Should in-studio camp be suspended at any time prior to the start of the in-person day camp period for Summer Dance Day Camp 2023 (August 2023) due to government regulations or a required RWB building closure, in-studio dance day camp will be cancelled. Should in-studio classes be suspended at any time during the in-person training period for Summer Dance Day Camp 2023 (August 2023) due to government regulations or a required RWB building closure, in-person dance day camp instruction will continue as distance learning via an online delivery method. The RWB School will make every reasonable effort to minimize disruption to existing programming.

Tuition Rebates

Should all in-studio programming be suspended at any time before the start of the in-person dance day camp period for Summer Dance Day Camp 2023 (August 2023), all students will receive a full tuition refund.

Should all in-studio classes be suspended at any time during the in-person training period for Summer Dance Day Camp 2023 (August 2023), requiring the RWB School to deliver classes via distance learning for **more than 3 consecutive class days**, students may be eligible for a partial tuition rebate. Rebates will be offered to eligible students for 30% of tuition fees pertaining to the distance learning period, from the beginning of the 4th consecutive class day, onward. All non-refundable ancillary fees are excluded from tuition rebate calculations.

Partial tuition rebates will be calculated **from the beginning of the 4th consecutive class day of distance learning** as follows: **(Tuition fees / # of days per session) x (# of days of distance learning – first 3 days of distance learning) x 30%**

Example: (\$ 300 tuition fees/5 days of programming) x (days of distance learning – first 3 days of distance learning) x 30% **Therefore:** (\$300* / 5) x (4-2) x 30% = \$36* rebate*

**Quoted fees are based on information at time of printing and are subject to change.*

In-studio suspension periods of 3 or fewer consecutive class days resulting in distance learning do not qualify for a rebate. During Summer Dance Day Camp 2023, the RWB School will monitor in-studio class suspensions resulting in periods of distance learning. If rebates are determined to be due, they will be calculated and applied as credits on account in September 2023 after the completion Summer Dance Day Camp 2023. Rebate summaries will be provided to those who qualify.

Not Eligible for Tuition Rebate

Students who have voluntarily withdrawn during Summer Dance Day Camp 2023 are not eligible for a rebate.

Students who have not attended programming during Summer Dance Day Camp 2023 due to illness or injury are not eligible for a tuition rebate.
